### Terms and Conditions

**ELIGIBILITY:** This offer is valid for Pepco residential customers applying through the Pepco VHEC program only. For other programs, please visit [pepco.com/SaveEnergy](http://pepco.com/SaveEnergy).

**VHEC:** A trained energy efficiency expert (the "Energy Analyst") will contact you by telephone or video call to assist you with VHEC delivery. You agree to recordation of such telephone or video call by the Energy Analyst and that such recording will be shared with Pepco. You are advised to retain a copy of these terms and conditions, and any installation instructions and accompanying documentation provided by Pepco and/or the Energy Analyst under this program. Pepco will not be responsible for lost documentation pertaining to this VHEC program. Details of this program, including direct-install energy-saving measures, are subject to change or cancellation without prior notice.

**APPROVAL AND VERIFICATION:** Pepco reserves the right to contact you by telephone to verify VHEC delivery and you agree to (i) answer, to the best of your ability, the questions Pepco may pose concerning such delivery and your experience with the Energy Analyst, and (ii) recordation of such telephone call. In addition, if requested by Pepco, you agree to provide, via a web portal or email address provided by Pepco for such purpose, photographic evidence of the installed VHEC measures.

**TAX LIABILITY:** Pepco will not be responsible for any tax liability that may be imposed on you as a result of the VHEC delivery and installation of the energy-saving measures. Please contact your tax adviser for more information.

**ENDORSEMENT:** Pepco does not endorse any particular manufacturer, product, system design, or contractor in promoting this program.

**INFORMATION RELEASE:** You agree that Pepco may include your name, Pepco services, and resulting energy savings in reports or other documentation submitted to Pepco and/or the Maryland Public Service Commission. Pepco will treat all other information gathered in evaluations as confidential and report it only in the aggregate.

**LIMITATION OF LIABILITY:** Pepco's liability is limited to paying for the time of the Energy Analyst and the energy-saving measures provided to you under this program. Pepco is not liable for any losses or damages, including, without limitation, loss of profits, loss of earnings, loss of business opportunities, property damage, or personal injuries (including death) resulting from or arising out of or with respect to participation in this program.

**PROPERTY RIGHTS:** You represent that you have the right to complete and/or install the energy-saving measures on the property on which those measures are completed and/or installed.

**RENTER'S CERTIFICATION:** If you are a renter, you certify that you have received consent from the landlord or homeowner for the receipt of the VHEC and associated installation of measures.

**RIGHT TO REFUSE:** The Energy Analyst has the right to refuse service or end the VHEC delivery when confronted by a customer acting inappropriately. Inappropriate behavior includes but is not limited to the following: unreasonable demands for service, personally threatening or offensive language, or threatening or erratic behavior.

**REPLACEMENT OR REINSTALLATION OF EQUIPMENT:** You agree, as a condition of participation in this VHEC program, to remove existing inefficient measures to be replaced under this program and to store or dispose of such inefficient measures safely and in accordance with all laws, rules, and regulations, and to replace such inefficient measures with the efficient measures received as a result of this VHEC program. You also agree not to reinstall any newly installed VHEC energy efficiency measures outside the premises where they were installed.
